Foster informed SLP that A574035 was showing pretty extensive reactivity towards other animals since leaving the shelter. Foster stated that A574035 will attack anything that shows her reflection. Examples of items she has attacked: mirrors, the refridgerator, a guitar, etc. Foster said that she has been trying to work on desensitizing her with her dog and has gotten A574035 close without heavy reaction, but the behavior has been consistent. Foster said she would send SLP video footage of her attacking an item, but that A574035 has been much worse than the footage. Foster said that it can be very difficult to get A574035 to calm down and get her to stop fixating and she has had to resort to covering A574035's head with a blanket when she becomes hard to control. SLP consulted with her about the behavior and how concerning it was. SLP asked Foster if she thought A574035 would hurt another animal if given the chance and Foster said yes. SLP consulted with Foster that A574035 may not be a safe candidate for adoption and SLP said she didn't want Foster or her dog getting hurt. Foster understood. Foster stated she would send the video footage and we would go from there.
